## Priscille Szeradzki appointed General Manager of the Confédération Nationale du Crédit Mutuel

Paris, January 15, 2026

The General Assembly of the Confédération Nationale du Crédit Mutuel, composed of the presidents of all Crédit Mutuel federations, today unanimously elected Priscille Szeradzki as General Manager. Her appointment will take effect on February 1, 2026. She succeeds Isabelle Ferrand, whose term of office began on May 1, 2023.

Priscille Szeradzki proposed Emmanuelle Revolón as Deputy General Manager, a choice that was confirmed by the Board, which met on the same day.

#### Priscille Szeradzki

Deputy General Manager of the Confédération Nationale du Crédit Mutuel since June 2023, Priscille Szeradzki is also Deputy General Manager of the Caisse Centrale du Crédit Mutuel (CCCM). She was elected President of the European Association of Co-operative Banks in June 2024. Before joining Crédit Mutuel, she held several positions within the Ministry of Economy and Finance, where she notably served as rapporteur for the Interministerial Committee for Industrial Restructuring, as well as at the Ministry of Foreign Affairs and, previously, at the French Office for the Protection of Refugees and Stateless Persons (OFPRA).



### Emmanuelle Revolton

Emmanuelle Revolton began her career in the banking sector in 1993 at Crédit Lyonnais, followed by the audit firm Constantin Associés. She joined the Confédération Nationale du Crédit Mutuel in 1999, first in the General Inspection department, then in the Finance Department where she held various positions before becoming Chief Financial Officer of the Confédération and the Caisse Centrale du Crédit Mutuel (CCCM) in 2019. In 2023, she was appointed Deputy General Manager in charge of Finance for the CNCM and Deputy General Manager of the CCCM. In parallel, she holds various mandates within organizations related to the banking, cooperative, and real estate sectors.
